NEW BUSINESS:

Case number 1601-0034 for Maurice Leuyckx and Susan Jefferson was called.

Maurice Leuyckx was present for this case and sworn for testimony.

Mr. Leuyckx provided his mailing address as 17130 NW 318th Street, Okeechobee, FL 34972. Officer Griffin presented the case for the property located at 17129 NW 318th Street which was cited for construction without a permit, 13.01.01. Mr. Leuyckx stated he had a meeting with Mr. Royce and they had a transcript which supposedly showed that he had authorization to build, however he wasn't given a copy. The paperwork Mr. Leuyckx has provided to the building department has been deemed insufficient.

Officer Albert stated she doesn't recall speaking with Mr. Alvarez and that typically zoning questions are referred to the zoning department. Mr. Alvarez then stated he sold the property last month.

Special Magistrate Hooker found the Respondent to be in violation of sections 10.02.02F, 10.02.02O, 13.01.01 and 7.09.01B. Special Magistrate Hooker ordered the Respondent to be in full compliance by removing the cited violations by November 12, 2020 or be subject to a fine of up to \$250.00 per day thereafter.

Case number 1912-0118 for Steven M Scherer and Lynn A Scherer was called.

Steven Scherer and Lynn Scherer were present for this case and sworn for testimony.

Mrs. Scherer provided their mailing address as 10064 Highway 70 East, Okeechobee FL 34972. Officer Griffin presented the case for the property located at 801 NW 39th Circle which was previously heard during the September 15, 2020 hearing and cited for trash and debris, 10.02.02D, outdoor storage, 10.02.02L and condition which constitutes a safety hazard, 10.02.02E. Property remains in violation.

Officer Griffin offered several supporting documents into evidence, which were admitted into evidence by Special Magistrate Hooker.

Special Magistrate Hooker found the Respondent to be in violation of sections 10.02.02D, 10.02.02L and 10.02.02E. Special Magistrate Hooker imposed a daily fine of \$2.00 to being on October 21, 2020 and will be filed at the Clerk of Court in no less than fourteen days.

Before the meeting was adjourned it was determined that the December 15, 2020 hearing is cancelled.
