No parties were present for this case.

Officer Gilchrist presented the case for the property located at 5928 SE 95th Trail, which was cited for abandoned/inoperable vehicles, 10.02.02B, trash and debris, 10.02.02D, overgrown weeds or grass, 10.02.02K, outdoor storage, 10.02.02L, condition of building, 10.04.00B. Property remains in violation.

Special Magistrate Hooker found the Respondent to be in violation of sections 10.02.02F and 2.07.00A. Special Magistrate Hooker ordered the Respondent to be in full compliance by removing the cited violations by May 13, 2021 or be subject to a fine of up to \$250.00 per day thereafter.

Case number CE2009-0269 for Charles E. Lepley Sr. was called.

Charles E. Lepley Jr. was present for this case and sworn for testimony.

Officer Gilchrist presented the case for the property located at 4344 SE 23rd Court, which was cited for abandoned/inoperable vehicle, 10.02.02B, trash and debris, 10.02.02D, overgrowth, 10.02.02K, and outdoor storage, 10.02.02L. Mr. Lepley Jr. stated that he is in the process of cleaning up the property and will try to have all violations cleared within the next few weeks. Property remains in violation.

Mr. Killino stated that he is going to help Mr. Rucks with his electrical issues and address the other violations. Property remains in violation.

Special Magistrate Hooker found the Respondent to be in violation of sections 10.02.02D, 10.02.02O, 10.02.03J, and 10.01.00A. Special Magistrate Hooker ordered the Respondent to be in full compliance by removing the cited violations by May 13, 2021 or be subject to a fine of up to \$250.00 per day thereafter.

Case number CE2005-0029 for Edwin Berle Rucks Jr. and Ashley E. Rucks was called.

Edwin Berle Rucks Jr was present and Frances Killino both were sworn for testimony.

Mr. Rucks provided his mailing address as 28320 NE 55th Avenue, Okeechobee, FL 34972. Officer Griffin presented the case for the property located at 28320 NE 55th Avenue, which was previously heard during the March 16, 2021 and cited for trash and debris, 10.02.02D, unauthorized use of land and/or building, 10.02.02F, overgrowth, 10.02.02K, outdoor storage, 10.02.02L, harborage for vermin, 10.02.03J, deterioration of building, 10.01.00A, encroachment of rights of way, 7.03.03C, and business without a license, 62.105C. Mr. Killino stated that he is going to help Mr. Rucks with his electrical issues and address the other violations. Property remains in violation.

Officer Griffin offered several supporting documents into evidence, which were admitted into evidence by Special Magistrate Hooker.

Special Magistrate Hooker found the Respondent to be in violation of 10.02.02D, 10.02.02F, 10.02.02K, 10.02.02L, 10.02.03J, 10.01.00A, 7.03.03C, and 62.105C. Special Magistrate Hooker ordered the Respondent to be in full compliance by removing the cited violations by May13, 2021 or be subject to a fine of up to \$250.00 per day thereafter.

Case number 1905-0050 for Emilio Juandumois Casamajor II and Andrea Conde was called.

Emilio Juandumois Casamajor II, was present for this case and sworn for testimony.

Mr. Casamajor provided the mailing address as 3917 Moultrie Road, Albany, Georgia, 31705-5164. Officer Griffin presented the case for the property located at NW 313th Street, which was previously heard during the January 19, 2021 hearing and cited for trash and debris, 10.02.02D, unauthorized use of land and/or building, 10.02.02F, overgrowth, 10.02.02K, outdoor storage, 10.02.02L, violation of minimum housing standards, 10.02.02O, occupied RV, 7.08.05, parking and storage of certain vehicles, 2.07.00A. There was discussion regarding Mr. Casamajor is living out of state and occasionally visits the property. It was agreed upon by the owner that the stipulation would be a fine would start on June 11, 2021 if the property is not in compliance. Property remains in violation.

Officer Griffin offered several supporting documents into evidence, which were admitted into evidence by Special Magistrate Hooker.

Special Magistrate Hooker found the Respondent to be in violation of sections 10.02.02B, 10.02.02D, 10.02.02F, 10.02.02K, 10.02.02L, 10.02.02O, 7.08.05, 2.07.00A. Special Magistrate Hooker ordered Respondent to be in full compliance by removing cited violations by June 10, 2021 and if not in compliance a fine would start at \$30.00 per day beginning June 11, 2021 and continuing per day thereafter.

ase number CE2001-0045 for Jeffrey Jones (deceased) and Susan L Frazier was called.

No parties were present for this case.

Officer Kinard presented the case for the property located at 8336 Hwy 441 SE, which was previously heard during the March 16, 2021 hearing and cited for unpermitted construction, 13.01.01. Property remains in violation.

Officer Kinard offered several supporting documents into evidence, which were admitted into evidence by Special Magistrate Hooker.

Special Magistrate Hooker found the Respondent to be in violation of sections 13.01.01. Special Magistrate Hooker ordered Respondent to be in full compliance by removing cited violations by May 13, 2021 or be subject to a fine of up to \$250.00 per day thereafter.

Case number 1912-0002 for Rhonda J. Beverly was called.

No parties were present for this case.

Officer Griffin presented the case for the property located at 18182 NW 278th Street, which was previously heard during the March 16, 2021 hearing and cited for unauthorized use of land and/or building, 10.02.02F, parking, storage and use of certain vehicles, 2.07.00A, unauthorized structures, buildings, containers, 7.09.01B and unpermitted construction, 13.01.01. Property remains in violation.

_____fficer Griffin offered several supporting documents into evidence, which were admitted into evidence by Special Magistrate Hooker.

Special Magistrate Hooker found the Respondent to be in violation of sections 10.02.02F, 2.07.00A, 7.09.01B and 13.01.01. Special Magistrate Hooker imposed a daily fine of \$30.00 to begin April 21, 2021 and remain in place until the property is brought into compliance. The lien shall be filed at the Clerk of Court in no less than 14 days.

REDUCTION OF FINE:

Case number 2203-0015 for Anthony Hatten was called.

Michael Hatten was present and sworn in for testimony.

Officer Albert offered supporting documents for the property located at 4141 SE 28th Street.

The fine ran from November 19, 2002, thru February 1, 2021, for \$250.00 per day reaching a total of \$1,662,250.00. It was discussed that Mr. Hatten was unaware of the violations on his father's property. The County then proposed an offer of reductions to the amount of \$2,000. Mr. Hatten agreed to the offer.

Special Magistrate Hooker recommended the reduction to the amount of \$2,000.00 to be presented for approval at the next Board of County Commissioner meeting.

ADJOURNMENT:

There being no further business, Special Magistrate Hooker adjourned the meeting.
